Divisional Forest Officer, Athgarh Forest Division, Athgarh on behalf of Governor of Odisha invite percentage bids in Single Cover in online mode for the Construction works as detailed in the table, from the class of eligible contractors as mentioned in column -6 having valid license from competent authority for execution of works as detailed below.

4. Bid documents will be available in the website www.tenderodisha.gov.in from 11.00 A.M. of dated 07.09.2023 to 5.00 P.M. of dated 22.09.2023 for online bidding.
5. Submission of Original documents (TP Cost, Bid security declaration, Affidavit in schedule-F) during office hours from dt. 23.09.2023, 10.30AM to 17.00 hrs in the office of the undersigned.

Note: Non submission of original documents like tender paper cost, bid security declaration & affidavit in schedule-F during the stipulated time period as mentioned above will be liable for rejection of tender.

6. The bidder must possess compatible Digital Signature Certificate (DSC) of Class-II & Class-III.
7. Bid shall be received only online on or before dated 22.09.2023 up to 5.00 P.M.
8. Bids received online shall be opened on dated 25.09.2023 at 11.30 A.M in the Office of the Divisional Forest Officer, Athgarh Forest Division Athgarh in presence of the bidders who wish to attend. Bidders who participate in the bid can witness the opening of bids after logging to the site through their DSC. If the office happens to be closed on the last date of sale on receipt of the bids as specified, the bids will be opened on the next working day at the same time and venue.
9. The bidder shall deposit the cost of bid document as mentioned in column No. 5 in shape of Demand draft drawn in favour of the "Divisional Forest Officer, Athgarh Forest Division, Athgarh" payable at Athgarh.
10. The bidder shall have to furnish a security declaration as per the Office Memorandum No. 8943 dated 18.03.2021 of Finance Department, Government of Odisha in lieu of the bid security in the format annexed, form of bid security declaration along with the bid.
11. Additional performance security have to be deposited by the bidder if the bid amount is less than the estimate cost as per amendment to Para 3.5.5 (V) of OPWD code Vol. I modified vide Works Department office Memorandum No. 4559 dated 05.04.2021 as given in DTCN.
12. Tenders in complete shape should be uploaded with valid registration certificate, PAN Card, GST Certificate, T.P. Cost, Affidavit in schedule-F in the prescribed format.
13. This is a time-bound work, to be completed within the stipulated period. The respective bidders are advised to study the scope of work and survey the site for constraints if any and assess their bid capacity and capability before submitting their tenders.
14. Other details can be seen in the bidding documents.
15. The authority will not be held responsible for any technical snag or network failure during online bidding.
16. The authority reserves the right to reject any or all tenders without assigning any reason thereof.
