Sealed tender in the prescribed form to be eventually drawn-up in Standard Forest Department Form P-1 (Percentage Rate Bids) in conformity with the Detailed Tender Call Notice is invited by the Divisional Forest Officer, Rourkela Forest Division, Rourkela on behalf of Governor of Odisha in **SINGLE COVER SYSTEM** only on **"ONLINE"** for the construction of works as detailed in the table below from **"D" & "C" Class Contractors** registered with the State Government and contractors of equivalent grade / Class registered with Central Government / MES / Railways for execution of Civil Works, on production of definite proof from the appropriate authority. 6. The bidders must possess compatible Digital Signature Certificate DSC of Class – II or Class – III.
7. Bids shall be received only **"Online"** on or before **05:00 P.M.** of dated **12.10.2023**.
8. Bids received online shall be opened at **11:00 AM** of dated **18.10.2023** in the Office of the Divisional Forest Officer, Rourkela Forest Division, Rourkela in the presence of bidders who wish to attend. Bidders who participated in the bid can witness the opening of bids after logging on to the site through their DSC. If the office happens to be closed on the date of opening of the bids as specified, the bids will be opened on the next working day at the same time and venue.

9. Engineering contractors who are desirous to avail the facility of exemption of EMD / ISD are required to submit the scan copy of affidavit along with bid document to the effect that he / she had not yet availed the facility during current financial year as per codal provision.
10. The SC / ST contractors willing to avail the facilities as fixed by Govt. will submit scan copy of the affidavit for the same along with tender document; otherwise, they will not be entitled to avail such facilities.
11. Additional Performance Security shall be submitted by the successful bidder when the bid amount is less than the estimated cost put to tender as per DTCN Clause.
12. The Original documents uploaded by the bidder in the eProcurement system of Govt. of Odisha pertaining to this bid shall be presented before the tender selection committee at 11:00 AM in the conference hall of DFO, Rourkela on Dt: 19.10.2023 for verification and finalization of tender.


