Interested and eligible participants having experience in similar nature of work are invited to submit the Detailed Project Report only, which shall include preparation of estimates, drawings and designs (AutoCAD soft copy and 3D views), bill of quantities, detailed technical specifications of materials to be used in the work, including analysis of labour and material components, etc., as per the current Schedule of Rates of the State PWD, Government of Odisha.

2. Receiving of Quotation Papers will from **Dt.19.10.2025, 10.00 AM to dt.28.10.2025 till 4.00 PM.**

3. Mode of submission of Quotation is Speed Post/ Registered Post/ Courier / directly put in the Quotation box of the Division Office only to the address as specified below during the office hour only. Submission of Quotation paper through any other mode and late tender will be rejected.

4. The Sealed quotation papers shall be opened on **Dt.29.10.2025 at 11.30 AM for Technical Evaluation and dt.30.10.2025 at 11.30 AM for Financial Evaluation** by Divisional Level quotation Selection Committee under Chairmanship of Assistant Conservator of Forests, Hirakud Wildlife Division, Sambalpur. The Tenderers or their authorized representatives are at liberty to remain present at the time of opening of the Quotation. Quotation papers found incomplete & received late shall be summarily rejected.

5. Period of Contract is 01 (One year) from the date of agreement and further extension or cancellation may be given based on review of performance which is at the discretion of the undersigned. The successful bidder/firm shall submit the Detailed Project Report (Plan, Design & Estimate) for Development of Debrigarh Ecotourism on or before **15.11.2025** positively.

6. The quotation should be submitted in two bid system i.e., "Technical Bid" and "Financial Bid". The technical bid should contain all the information's relating to his eligibility along with cost of tender paper in appropriate shape. The technical bid and financial bid required to be submitted in two separate envelopes clearly mentioning on top of the envelope "Technical Bid" and "Financial Bid" respectively and both of these should be placed in a big envelope marked with The sealed offer must be superscribed in bold letters with " Appointment of an Architectural Consultant for providing a Detailed Project Report (Plan, design and estimate) for the Development of Debrigarh Ecotourism under Hirakud Wildlife Division, Sambalpur.

7. The fees will be inclusive of all costs for rendering the services (Plan, design and estimate) as defined in the "Scope of work". The "value of work" will be reckoned based on bill amount accepted by the DFO, Hirakud Wildlife Division, Sambalpur in respect of the executed works for which the consultancy services have been availed.

8. The fees payable for the consultancy services will be for the Plan, design and estimate and shall be linked to the value of the project awarded by the DFO, Hirakud Wildlife Division, Sambalpur, for which the services of the consultant have been engaged. Hence, the fees or service charges must be quoted in percentage terms (including all TAX) for value of works executed by the DFO, Hirakud Wildlife Division, Sambalpur and for which services have been rendered by the applicant.

9. The firm should have its registered office located at Sambalpur & adjoining (nearby) districts.

10. The eligibility criteria and all other terms and conditions will be available in Divisional Notice Board as well as in Tender paper with effect from 10.00 AM of 19.10.2025 to 4.00 PM of 28.10.2025.

11. The applicant shall, with prior approval of the DFO, Hiraakud Wildlife Division, Sambalpur and within his fees, engage the services of well qualified staff/specialist or consultants pertaining to services indicated below and will be broadly responsible for all the following works:

a. Rendering end to end services as required by DFO, Hiraakud Wildlife Division, Sambalpur including consultancy services for various architects works i.e Plan/designs/drawings/taking statutory approvals etc.

b. Preparation of 2D/3D designs with cost estimates as required in the Detailed Project Report for the Development of Debrigarh Ecotourism.

12. Bidders who will not meet the eligibility criteria mentioned in tender document will not be considered for further evaluation and their bids will be out rightly rejected.

13. The Decision of the Selection Committee about determining the selection of the Architectural Consultant shall be final. The DFO, Hiraakud Wildlife Division, Sambalpur is not bound to assign any reasons therefore and reserve the right to reject any or all offer.

14. The agency/ firm or Architect or consultant selected for assignment shall be required to execute an agreement on non-judicial stamp with required stamp duty (₹ 200/-) in the prescribed format. The stamp duty will be borne by the empanelled agency. Payment of professional fee shall be made in staggered manner depending upon progress of work.

15. The authority has the right to reject the offer at any stage of the bid including selection process without assigning any reason thereof.
