2. Experience Criteria: The Bidder should have supplied Camera traps to any Govt. Department of Odisha Government for any one of the last two year before the bid opening date. Copies of relevant contracts to be submitted along with bid in support. (Copy of Purchase Order / Supply Order / shall be submitted by the bidder for technical qualification). Tampering of Purchase Order / Supply Order / in any form, the bidder shall be rejected in the technical bid.
3. The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25% of the bid quantity at the time placement of contract. Bidders are bound to accept the orders accordingly.
4. O.E.M or Authorized Seller of O.E.M are be allowed to participate in the BID. The certificate to this effect should be submitted.
5. **All bidder willing to participate in the Technical Bid, shall have to send their sample along with manual to the DFOs office at Athmallik physically or by post. All Camera traps received will be tested in the Field both Day and Night by Expert Members having experience in the Field of Wildlife as per the parameters floated. Only those bidders who pass the field test shall be accepted for technical qualification and others shall be disqualified in Technical Bid. The sample shall reach this office on or before the bid closing date.**
6. **The bidder at their own arrangement shall take back the sample along with the accessories after generation of contract. This office shall not take any responsibility for returning of the samples.**
7. The bidders are requested to submit the details about their product in their letter head, duly signed during submission of technical bid. Basing on their product specification, and other requirement as per the terms and conditions in the BID technical evaluation shall be made, thereafter acceptance of technical BID.
