- 08. Copy of GST clearance and Income Tax should be accompanied along with the tender.
- 09. Payment will be made through RTGS / MGNREGS Soft after receipt of all the materials orderedwith checking of quality and quantity of the materials.
- 10. The tenderer should clearly mention the Bank A/c Number, Bank Address and IFSC Code in whichthe payment will be made.
