- 4. The bidder shall transfer the cost of Bid Documents as mentioned in Col.7 of table above towards the cost of bid through a process as mentioned under DTCN.
- 5. Bid documents will be available online on the above websites.
- 6. Bidders must possess a valid Class-II Digital Signature Certificate (DSC).
- 7. Bids shall be received "On-line" shall be opened on 16.12.2025 the office of the Divisional forest officer Athmallik, in the presence of bidder/authorized agent of bidders who wish to attend. Bidder who participated in the bid can witness the opening of the bids after logging on to the site through DSC. If the office happens to be closed on the stipulated date of opening of Bids as specified, the bids will be opened on the next working day at the same time and venue.

10. Engineering contractors desirous of availing EMD exemption shall submit a scanned copy of an affidavit along with the bid document, declaring that they have not availed the facility during the current financial year as per codal provisions.

11. SC/ST contractors willing to avail Government-approved facilities shall submit a scanned copy of the relevant affidavit along with the tender documents; otherwise, they will not be entitled

to such facilities

12. Additional Performance Security shall be submitted if required, as per DTCN.

13. Addendum/Corrigendum will be hosted in the website only.

- 14. The authority reserves the right to cancel the bids without assigning reason.
- 15. In case of equal lowest bids, lottery will be conducted and bidders will be informed.

16. Quantities in BOQ may be modified without altering sanctioned amount.

- 17. Bidders are to submit the original BOQ uploaded by Publisher after entering relevant fields without any alteration/ deletion/modification. Multiple BOQ submission shall lead to cancellation of bid.
- 18. As it is a percentage rate tender, the bidder quoting zero value is valid and will be taken as schedule rates.
- 19. Additional performance security shall be submitted by the successful bidder if the bid amount is lower than the estimated cost put to tender as per DTCN clause.
