**TERMS & CONDITIONS FOR HIRING OF VEHICLES**

The following terms and conditions must be fulfilled by the successful bidder for providing a vehicle on hire for monthly rent basis.

1. Tender inviting authority reserves all the rights of accepting or rejecting one or more tender offer(s) or cancelling the tender without assigning any reasons thereof.
2. Vehicles will ordinarily be deployed within the jurisdiction of respective Ranges of Brahmapur Forest Division and may sometime be deployed elsewhere within the State. The period of engagement is **up to 31.03.2025 or expiry of the scheme whichever is earlier.**
3. The vehicle must be in Road Worthy condition, shall not be more than **3 years old** from the date of initial registration and must have valid Registration Certificate, Insurance Certificate, Fitness Certificate, Commercial certificate, Valid Contract Carriage Permit, proof of up-to-date tax payment etc. which are mandatory for plying of vehicle.
4. The Driver of the vehicle must have a valid Driving License for driving light transport passenger vehicle and should be sufficiently experienced in driving transport passenger vehicle.
5. The Driver should be well behaved, gentle and obedient in nature.
6. The Bidder will supply the vehicle fitted with **GPS Tracking module** (as directed by concerned Ranger) without any extra cost.
7. Bidders are to submit the **TECHNICAL BID and FINANCIAL BID in a two Separate Sealed Cover** quoting price in FINANCIAL BID for the vehicle intend to supply and both the cover to be enveloped in one Cover and dropped in the Drop Box.
8. A sum of **Rs. 5000/- (Rupees Five Thousand) only** for each vehicle for which rate is quoted shall be deposited by the intending bidders in shape of Account Payee Bank Draft drawn in favour of the Divisional Forest Officer, Brahmapur Forest Division payable at Brahmapur and submitted along with the tender documents as **security deposit**. After completion of tender process, the amount will be refunded to unsuccessful bidders. In case of successful tenderers, the tender security will be converted to performance security. The performance security or security deposit is liable for forfeiture in full or part on violation of terms and conditions or on default to placing vehicle on being successful bidder.
9. The monthly rate of hire charge is to be quoted separately in the general bid information (Excluding fuel and lubricants) **(Annexure-I)**.
10. The Vehicle must achieve fuel efficiency of **10 or above K.M. Per liter**. The tenderers quoting higher fuel efficiency i.e. more number of kilometers per liter of fuel consumption will be taken into consideration along with the quoted hiring charges for deciding the cost effective tender offers. Other criteria and terms and conditions will also be applicable for the same. Therefore, all such offers must fulfill the criteria as laid down in the terms and conditions, of this tender document.



11. The details of the make and year of manufacture of the vehicle, registration No. mileage (Kms covered per liter) and name of the Driver with Driving License No. and period of validity should be specifically provided in the general bid information to be furnished with the Quotation/Tender (**Annexure-I**).
12. The Quotation completed in all respect should reach the undersigned on or before **21.06.2024** by **05.00 PM** Noon and shall be opened on **25.06.2024 at 11.00 AM**. in presence of the bidders or their authorized representatives.
13. The application form of quotation/ tender containing General Bid Information and Terms and Conditions for Hiring of Vehicles etc. can be downloaded from the website **odishaforest.in/ganjam.nic.in** will be available from **07.06.2024** to **21.06.2024**. The Tender form is downloaded from Govt. website, the applicant shall furnish a demand draft for an amount of **Rs. 1000/- (Rupees one thousand) only** towards the **cost of Tender Paper** along with the Technical Bid.
14. All the stipulations, terms and conditions of tender documents and notice for hiring of vehicles, including the **Annexure-I** are applicable and must be adhered to. The tenderers should also upload the signed copies of tender documents including the terms and condition in **Annexure-I**.
15. The stipulations and terms and conditions embodied in the tender document will form a part of the agreement.
16. The hired vehicle, during the period of contract shall have necessary valid MV document such as: -valid Registration Certificate, Insurance Certificate, Fitness Certificate, valid Contract Carriage Permit, proof of up-to-date tax payment etc. and D.L of the driver available all the times. The Department/Office hiring the vehicles shall not be responsible for any damage/loss caused to hired vehicles or loss of life/injury made to any person or damage to any property on account of use of hired vehicle in any manner whatsoever. The owner / successful tenderer, whose vehicle is hired, shall be responsible for all such litigation. Salary of driver, repair and maintenance charges and other cost including taxes (except service tax on hire charges) shall be borne by the successful tenderers/service providers.
17. The hire charges to be paid for monthly basis is final but does not include cost of diesel, which is to be paid separately basing on actual consumption and lubricants as per existing Government norms. All the expenditure of the vehicle towards repair, replacement of spare parts, lubricating oil of Engine, Gear Box and differential Coolant, Tyres & Tubes, Battery etc. will be borne by the bidder.
18. It shall be the responsibility of the bidder to provide a good driver and the salary of the driver shall be borne by the owner.
19. In case of breakdown of vehicle for reasons whatsoever the replacement of a vehicle of the same or better model shall be provided by the owner of the vehicle/successful bidder.
20. In case the vehicle does not report regularly, the authority will be at liberty to reject the agreement and may engage vehicle from another source.

21. In case of emergency, the driver will have to report for duty as per the requirement of hirer. No extra payment shall be demanded.
22. The vehicle shall report for duty for **minimum of 25 days** in a month. On the date of absence prior intimation is to be given to the hirer.
23. Monthly hire charges and reimbursements towards cost of fuel (as per actual) and lubricants (as per Govt. norm) of selected bidder will be paid in every succeeding month, as far as possible within fifteen days of the submission of bills by the service provider and no advance payment will be made.
24. The vehicle shall **not be more than three years old** from the initial registration and also in good running condition during the period of contract.
25. If the services are found to be unsatisfactory, the client shall **give one-month notice** and terminate the agreement.
26. In case the service provider intends to withdraw the services of the vehicle and terminate the agreement, it shall be mandatory upon him to grant **one month notice** before such withdrawal of service and termination of agreement.
27. If the bidder violates any of the terms of contract, Government shall **forfeit the entire amount of security deposit**.
28. This should be ensured by the Service Provider that the vehicles are kept under optimum running condition and avoid accidents attributable to lack of maintenance/ upkeep. The hired vehicles cannot be used for any private/ commercial purpose beyond office hours or during holidays.
29. Log books shall be maintained for the hired vehicles as in the case of Government vehicles. Kilometer reading and POL drawn shall be necessarily recorded in relevant columns and verified regularly by an authorized officer before making payment.
30. **GST, Gem , PAN and Company Registration are compulsory for any Service Provider** to provide hired vehicles to Government offices through GeM or through open bidding.
31. The successful tenderers will have to execute and sign the agreement with the concerned heads of office who will be approving authorities and will control the movement of their respective vehicles and pay the monthly hire charges and the reimbursement of diesel, lubricants as per terms and conditions and stipulations of this tender by observing the required official formalities.
32. Modifications, if any in Tender document or terms and conditions, will be notified only on the Website and advertisement where the tender document has been uploaded. The tender inviting authority reserves all the right to modify/cancel the terms and conditions of tender without assigning any reasons thereof before the last date of submission of tender documents.

**A. Preliminary Evaluation**

1. Bid fee: Bids without the bid fee will not be accepted. The bidders are required to submit bid fee as per following details: -  
**Non-refundable Tender fee of Rs.1000/- (Rupees one thousand) only and refundable security deposit of Rs. 5000/- (Rupees five thousand) only** shall be in the form of Account Payee Bank Draft drawn in favour of the Divisional Forest Officer, Brahmapur Division payable at Brahmapur as **Security Deposit**.
2. Bids submitted beyond the specified date and time shall not be accepted.
3. The Technical Bid and Financial Bid shall be submitted in **two Separate sealed cover**. Noncompliance to this two Bid System will be lead two rejections of the bidders.
4. The bidder must have an office with regular Telephone connection at Brahmapur.
5. The bidder should submit a declaration to the effect that neither the bidder themselves nor any of its allied concerns, partners or associates or directors or proprietors involved in any capacity are currently serving any banning orders issued by any govt. department debarring them from carrying on business dealing with any government department.
6. The travel firm submitting the bid should be located within the Ganjam District nearer of O/o the DFO, Brahmapur Forest Division Office, Brahmapur.
7. The vehicle shall be registered/ associated with the bidder and **shall not be more than three-year-old** as on the date of invitation of bid.


