The sample shall reach this office on or before the bid closing date.**
5. **The bidder at their own arrangement shall take back the sample along with the accessories after generation of contract. This office shall not take any responsibility for returning of the samples.**
6. The bidders are requested to submit the details about their product in their letter head, duly signed during submission of technical bid. Based on their product specification, the BID technical evaluation shall be made, thereafter acceptance of technical BID.
